

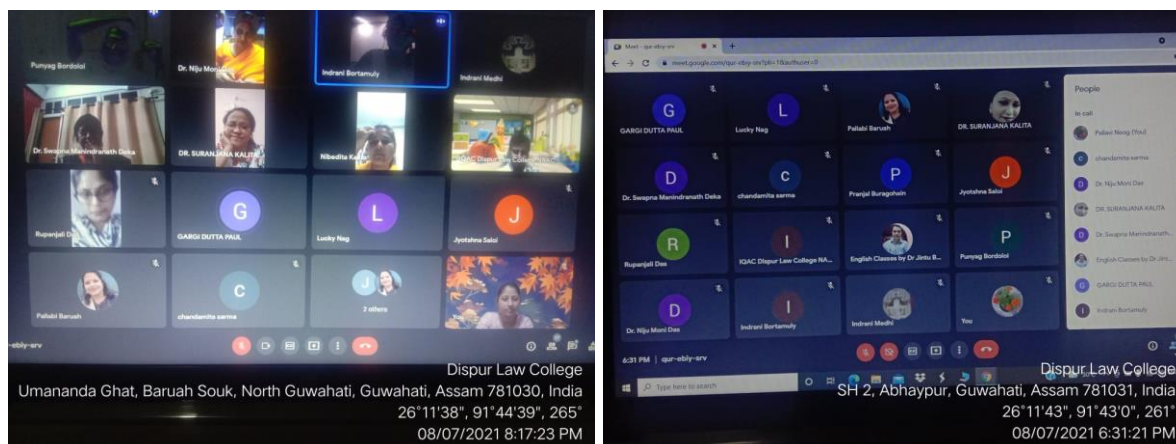


Fig.1:Faculties of Dispur Law College

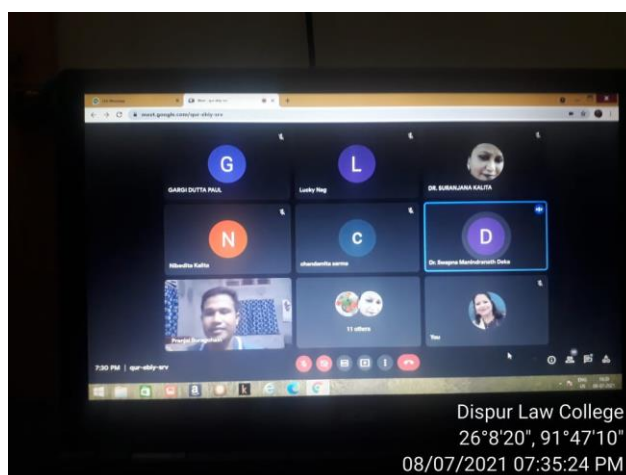


Fig.2: Resource Person delivering lecture on neurological characteristics of adolescent and behavioural dealing of the faculties.

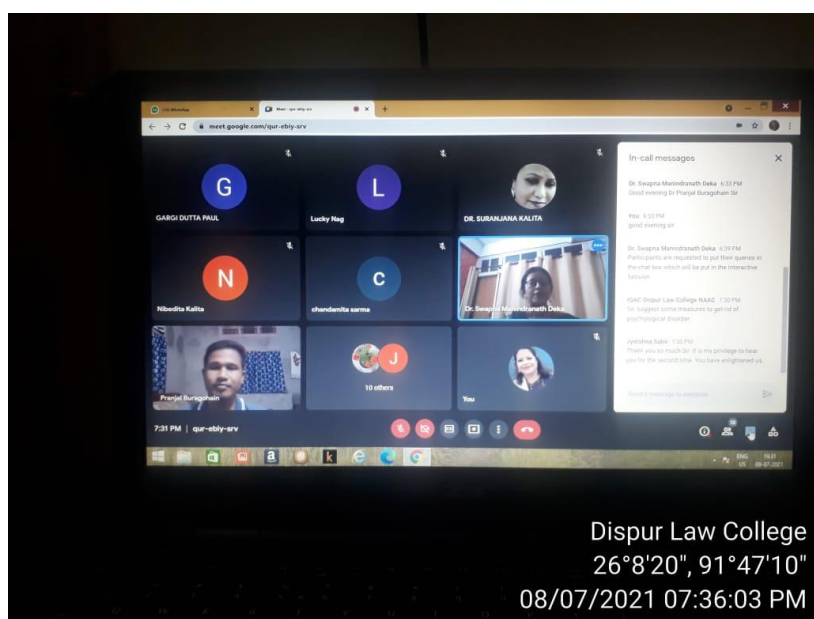


Fig.3: Closing of the program
