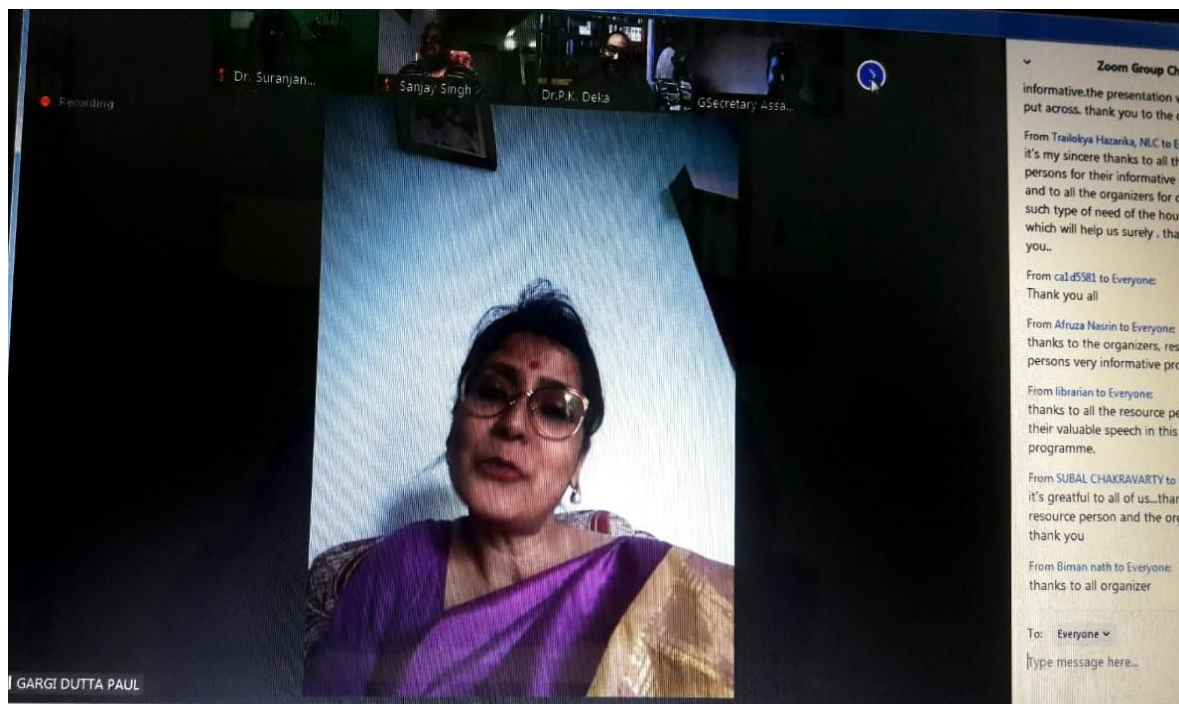


Fig.2: Dr. Gargi Dutta Paul, Principal Dispur Law College addressing the participants and the dignitaries

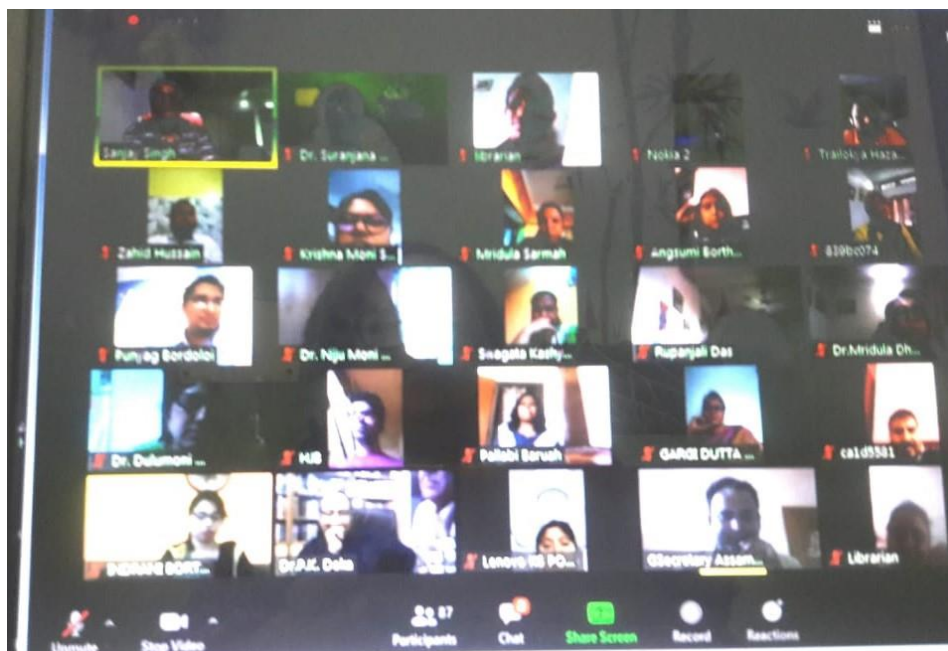


Fig.3: Participants in the ZOOM platform
