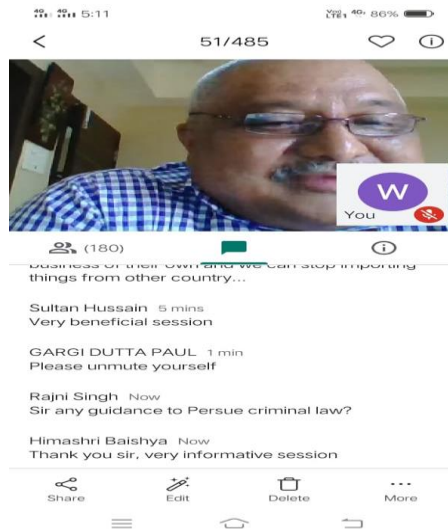


Fig.2: Resource Person of Day-1 Mr. Manoj Kumar Das

Dr. Gargi Dutta Paul, Principal, Dispur Law College, delivered the Welcome Address of the Day-1 of the Webinar where Mr. Manoj Kumar Das, Former Director, IIE, MD, NERAMAC; Head, A&C NEDFi was the resource person. He talked extensively on the untapped natural resources of Assam and how it can be utilized by people by harnessing the skills of an entrepreneur. He also talked about the present academic scenario where much emphasis is not laid on imparting knowledge on the skill of an entrepreneur.

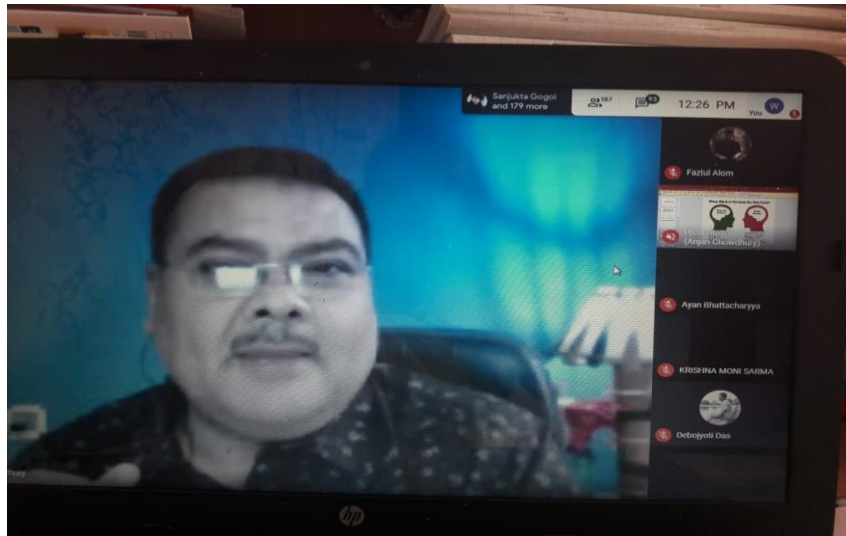


Fig.3: Day-2 Resource Person Mr. Anjan Choudhury
