Mrs. Kaberi Sharma in her valuable speech has highlighted different issues related to human trafficking and shared her experiences as a General Secretary of GOLD.

In beginning of the speech, Mrs. Sharma has stated that we celebrate the International Women’s Day to appreciate woman for reaching her personal as well as professional goals. The speaker has talked about the campaign theme “Choose to Challenge” for International Women’s Day 2021. She has described the pathetic conditions of the victims of human trafficking and explained the three components of trafficking such as means, activities and purposes of trafficking. The speaker talked about a number of instances of men who became the victims of trafficking for the purpose of blood harvesting and also the instances of women who were found as victims of trafficking for the purpose of child plantation. The speaker further stated that trafficking is an organized crime and the traffickers are criminals which include transporters, financiers, abettor

conspirators, and clients. The speaker also said that as per NHRC's Action Research Study Report on Trafficking in Women and Children in India (2005), there is a very low level of awareness about the crime of trafficking among the police personnel. Lastly, the speaker urged for creation of awareness among people about the problem of human trafficking and advised all to respect women in order to achieve the objective of celebrating the International Women's Day.
