Concept Note

Independence Day also popularly known as 15th August marks the end of British rule in India and the establishment of India as a democratic, republic, sovereign and independent nation. It also marks the anniversary of the partition of the subcontinent into two countries, India and Pakistan which occurred at the midnight on August 14–15, 1947. Independence Day reminds the country's citizens of all the sacrifices the freedom fighters have made to secure the country's future. Since its independence, India has made stellar progress in every field, including education, military and space programmes.

Indians across the nation will be commemorating India's independence from British rule by celebrating its 75th Independence Day on 15th August, 2021. Owing to the ongoing coronavirus pandemic Dispur Law College has decided to celebrate Independence Day by organising online competitions of recitation and essay writing for the students along with flag hoisting and plantation programmes.

A. Essay- Competition- The information about the essay competition are as follows-

1. **Topics** - The topics for the essay competition are as follows-

- 1) Lost In History: Unsung heroes of freedom movement;
- 2) Mahatma Gandhi and his contribution to the freedom movement.
- 3) Role of Constituent Assembly in framing the Constitution of India.
- 4) Secularism under the Indian Constitution.

2. **Guidelines** – The rules and regulations for the essay competition are as follows-

- 1) Students can choose any one or more of the above topics;
- 2) The essays are to be typed in the following format:

- i) Font size: 12
- ii) Font style: Times New Roman
- iii) Spacing: 1.5
- iv) Word limit: 1000-1500 words
- v) Last date of submission: 10th August 2021
- vi) Declaration of Results: 15th August 2021
- vii) The essays written on topic 1 and topic 2 are to be submitted to Dr. Indrani Medhi (whatsapp number 7086043715; email Id- imedhi10@gmail.com); and on topics 3 and 4 are to be submitted to Dr. Nijumoni Das (whatsapp number 8822841315; email Id - nijumonidas2012@gmail.com)
