“LETS IMPROVE OURSELVES”

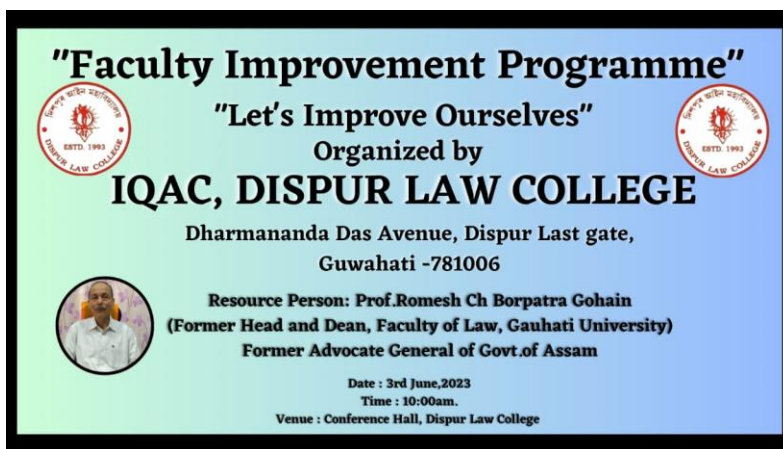

Prof. Ramesh Chandra Borpatragohain, former Dean of Faculty and former Advocate General of Assam was invited as a guest of honor and he chaired the Resource Person of the interaction session on 3rd of June 2023. The program was started with a welcome address delivered by Principal Dr. Gargi Dutta Paul. Principal Madam has welcomed the Honourable Resource Person Prof. Ramesh Chandra Borpatragohain. Honourable Resource Person Prof. Ramesh Chandra Borpatragohain has started his speech with welcoming note to the participant. He mainly laid stress on various field of Research Orientation programs. He also laid stress on various Extension Services and how Extension Services are important for Higher Educational System.

He focused how legal system came to India. After the comings of the Britishers the Modern Legal system has introduced by the Britishers. He also focused how Western Legal System and Philosophy applied in India. Though various written and unwritten rules and regulations were there in India before the British period but these rules and regulations were not identified as Law. He also mentioned John Rawl's theory of Principles of justice and Manu's theory of justice. According to him in 1934 a great philosopher stated that Western Philosophers are seems to be a child. He again said that in any disciplines we must synchronizing and harmonizing the various ideas. Then he discussed in details about the Kesavananda Bharti's Basic Structure Theory. Prof. Ramesh Chandra Borpatragohain Sir has mentioned that before Kesabananda Bharti the idea of basic interest of the Constitution was there mentioned in the 'Objective Resolution'.

According to him while interpreting the Constitution of India we cannot separate the various articles. Then Prof. Ramesh Chandra Borpatragohain Sir has discussed in details the various Articles of Indian Constitution. Sir has suggested that if the existing or old laws are not transformed then our protection will be on static. He raised a query whether the various legislative measures initiated by Britishers are good or should these be transformed. He also said that in a developing country like India there must be Occidental and Oriental ideas and these must be harmonizing, socializing or synchronizing. He suggests that as oil and water never be mixed up naturally but artificially which is also happen in Indian Constitution it means East and West interpretation never be match. According to him time is there to change the Laws. A report on this says that the present Constitution is just a vogue, should this be changed or newly implemented. Prof. Ramesh Chandra Borpatragohain Sir has focused that we cannot separate Law from literature, Law from economics and Law from culture.

At the last part of his lecture Prof. Ramesh Chandra Borpatragohain Sir has suggested various measures for the healthy practice of the institution.

1. He suggests that various soft skill development of the teachers.
2. Academic upliftment of the teachers or self -improvement of the teachers are important.
3. He also suggests remedial classes for the students.
4. He also advised the teachers to handle the students with care.
5. Institution should introduce Choice Based Credit System.
6. He suggests Orientation Program with the students and parents at the beginning of the course.
7. Orientation Program should also be introduced for the question setters and the paper evaluator.

Finally, the program was ended with a vote of thanks offered by Kamal Medhi, assistant Professor of Dispur Law College. This program may be fruitful for the faculty members of Dispur Law College.
