II. COURSE DESCRIPTION

Professional Ethics is a mandatory paper prescribed by the Bar Council of India and is also a compulsory subject for the All India Bar Examination and Advocate-on-Record Examination. The course integrates the principles of professional conduct, discipline of advocates, contempt of court, professional misconduct, and professional accounting system, along with practical exposure through Legal Aid Camps.

III. COURSE OBJECTIVES

The course aims to:

1. Provide a comprehensive understanding of legal provisions, rules, guidelines and landmark judicial decisions governing professional conduct of advocates and the law of contempt of court.
2. Examine decisions and opinions of the Bar Council of India and State Bar Councils relating to professional misconduct.
3. Familiarize students with the basic principles of professional accounting, office management, and financial responsibilities of advocates.

4. Develop social responsibility among students through Legal Aid and Legal Literacy Programmes.
5. Bridge the gap between theoretical knowledge and practical legal profession.

6. Course Description

This course is a mandatory paper prescribed by the Bar Council of India and is also compulsory for the All India Bar Examination and Advocate-on-Record Examination. The course deals with professional conduct of advocates, disciplinary mechanisms, contempt of court, professional accountancy, and legal aid activities, with practical exposure through Legal Aid Camps.
